NOTE: 2/3 majority vote of those voting required for passage because of lack of advanced notice of amendment to a previously passed motion, in this case, a Standing Rule.

1. Change 20-2 (5) <u>from</u> "The Comanche Flyer is sent 1st Class Air Mail to all foreign members" <u>to</u> "The Comanche Flyer is sent the most economical way to all non-Canadian foreign members".

Motion: Ron Keil made the above motion; Beryl Grant seconded the motion; the motion carried unanimously.

2. Change 20-2 (6) <u>from</u> "All maintenance tips are sent to our technical Committee for approval before printing" <u>to</u> "All maintenance and operational tips will be sent to our Technical Resources Committee for approval before printing."

Motion: Pat Donovan made the above motion; Ron Keil seconded the motion; the motion carried unanimously.

3. Change 20-2 (10) <u>from</u> "Officers, Board Representatives, and Tribe Chiefs names, addresses, emails, and telephone numbers will be published monthly in the Comanche Flyer." <u>To</u> "Officers, Board Representatives, and Tribe Chiefs names, addresses (city and state as a minimum), emails, and telephone numbers will be published monthly in the Comanche Flyer."

Motion: Beryl grant made the above motion; Pat Donovan seconded the motion; the motion carried unanimously.

4. Change 20-2 (11) from "The President of the International Comanche Society is the Editor-in –Chief of the Comanche Flyer and will have final authority over whatever letters and articles are printed." to "The President of the International Comanche Society is the Editor-in –Chief of the Comanche Flyer and will have final editorial authority over what is printed."

Motion: Pat Donovan made the above motion; Beryl Grant seconded the motion; the motion did not pass.

5. Add new item 20-2 (16) "Submissions are subject to editing and revision unless specifically requested to be published as submitted. The right is reserved to publish or not, any submission".

Motion: To <u>not</u> accept the new standing Rule. The motion passed. (Therefore the addition was not approved)

6. Change 20-2 (2) <u>from</u> "The cover photograph must include a member's Comanche, preferably in flight, as a prominent part of the cover. The aircraft may be added to an existing background photograph by photographic or electronic means." <u>Add to the above:</u> "The Editor-in-Chief, under extraordinary circumstances, may authorize a cover photograph of other than a Comanche. He is to inform the Board of such decision before final makeup of the issue."

Motion: Av Shiloh made the above motion; Phil Hobbs seconded the motion; the motion carried unanimously.

<u>NOTE:</u> The only instance that Hank Spellman recalls, was the issue honoring Maurice Taylor.

7. Change 20-2 (9) <u>from</u> "The Comanche Flyer will contain classified ads, and the fee for Comanche's For Sale ads shall be \$50 for two issues." <u>To</u> "The Comanche Flyer will contain classified ads, and the fee for Comanche's For Sale ads shall be \$50 for two issues except that the fee shall be reduced to \$25 for two issues for ads commencing in any issue beginning with the November, 2013, issue".

Motion: Pat Donovan made the above motion; Av Shiloh seconded the motion; the motion carried unanimously.

8. Change 30-3 (8) from "The selling price of the Tips Books in \$60 plus S&H, to members only." To "The selling price of the Tips Books in \$65 plus S&H, to members only."

Motion: Pat Donovan made the above motion; Berl Grant seconded the motion; the motion carried unanimously.
